SECTION 4: FIRST AID MEASURES (continue)

SECTION 5: FIREFIGHTING MEASURES

5.1 Extinguishing media:

Product is non-flammable under normal conditions of storage, manipulation and use. 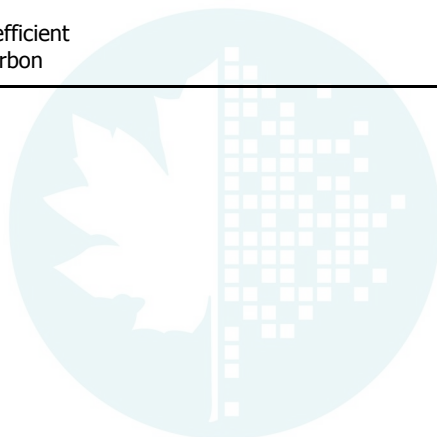
